Introduction

The VET Industry Curriculum Framework course information is designed to:

- assist students in planning their courses of study for the Higher School Certificate (HSC)
- provide succinct information to parents about HSC VET courses
- assist teachers, schools and Registered Training Organisations (RTOs) delivering HSC VET courses in providing accurate course information to students.

This document includes individual course information for the 120 HSC indicative hours courses, the 240 HSC indicative hours courses and, where applicable, the 360 HSC indicative hours courses in each of the VET Industry Curriculum Frameworks available in the HSC. Information on specialisation study courses and school-based apprenticeship pathway courses (if applicable) are available in the Syllabus for each Framework.

The course information seeks to summarise the HSC course requirements and the Australian Qualifications Framework (AQF) VET qualification/s to which the course relates. A brief statement regarding potential employment outcomes is also included.

It is emphasised that this is summary information only and that definitive information on HSC curriculum, assessment and certification should be sourced from the Syllabus(es) and Assessment and Reporting document for each Framework and from the Board of Studies [Assessment, Certification and Examination \(ACE\)](#) website.

The course information has been designed, as far as possible, to assist schools/RTOs in addressing requirements for providing information to students specified in the VET Quality Framework [formerly the Australian Quality Training Framework (AQTF)] standards for VET.

Course information can be adapted to tailor details to their particular school/college/RTO. Care must be taken to ensure this does not compromise the accuracy of the information.
